RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
CHULA VISTA APPROVING THE RE-CERTIFICATION OF  
THE CITY OF CHULA VISTA SEWER SYSTEM  
MANAGEMENT PLAN

WHEREAS, the State Water Resources Control Board adopted Order Number 2006-0003-DWQ requiring any public entity that owns or operates a sanitary sewer system greater than one mile in length to implement a Sewer System Management Plan; and

WHEREAS, the San Diego Regional Water Quality Control Board adopted Order Number R9-2007-005 that recognized the State order and mandated additional requirements regarding the management of the sanitary sewer systems; and

WHEREAS, on April 28, 2009 the City of Chula Vista City Council approved the Sewer System Management Plan (SSMP) to meet State and Regional requirements; and

WHEREAS, internal biennial audits were completed since initial approval typically presented to the City of Chula Vista City Council as an Informational Item; and

WHEREAS, Order Number 2006-0003 requires, that the City of Chula Vista's City Council approve the SSMP when significant updates are made; and

WHEREAS, the 2021 SSMP included significant minor changes, considered to be significant overall changes.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Chula Vista does hereby approve the City of Chula Vista's 2021 Sewer System Management Plan.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chula Vista, that it approves the 2021 City of Chula Vista Sewer System Management Plan, in the form presented a copy of which shall be kept on file in the Office of the City Engineer.
