PROPERTY DESCRIPTIONS

EVIDENCE COLLECTION

- ▶ Dust for prints first, then swab for DNA
- ▶ Get Elimination prints
- ▶ Get Elimination swabs
- ▶ Document how many drivers of vehicle (need eliminations for each person who handled item in question)
- ▶ Photos of evidence location

EVIDENCE COLLECTION

- **Victim handled evidence**
 - **Still of evidentiary value**
- **Rain/Water**
 - **Still of evidentiary value**

- **Vehicle Inside Garage**
 - **Print Outside of Vehicle**
- **Series Related**
 - **Print Outside of Vehicle**

CELL PHONE EVIDENCE

- Password or pattern to unlock phone.
- Cell phone evidence bins.



VIDEO EVIDENCE

- ▶ Axon Citizen Link
- ▶ Department Phone to capture video.
- ▶ Contact Information/Availability for the person who has access to the video.



5150 & PROPERTY CRIME

CONSIDERATIONS INVOLVING PEOPLE BELIEVED TO HAVE 5150 BEHAVIOR.

- If subject committed crime?
- If Bookable...
- If Not bookable...

459 PC VS 459.5 PC

488 PC VS 487 PC

- In most cases, if business is open and theft occurs inside business = 459.5 PC
- If business is closed = 459 PC
- 487 PC = Theft of any item valued over \$950



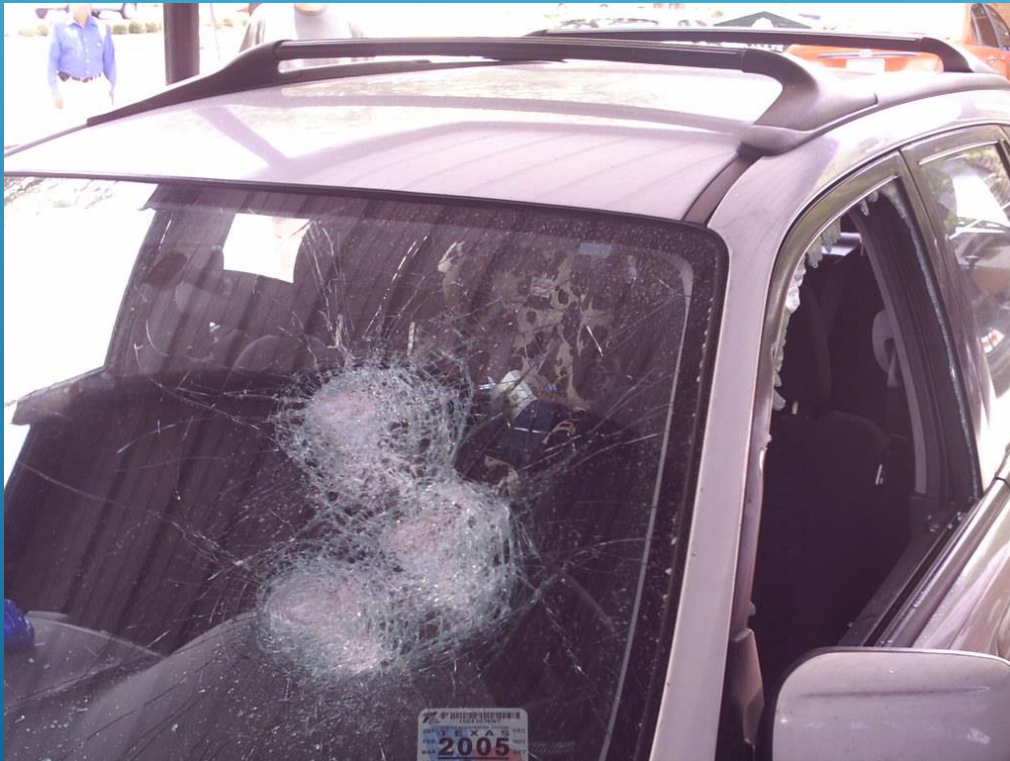
10851 CVC Stolen Vehicles

CIVIL OR CRIMINAL

594 PC VANDALISM

- ▶ Need estimate for damage
- ▶ Security footage
- ▶ Collect any instruments of the crime left behind
- ▶ Any potential suspect(s)

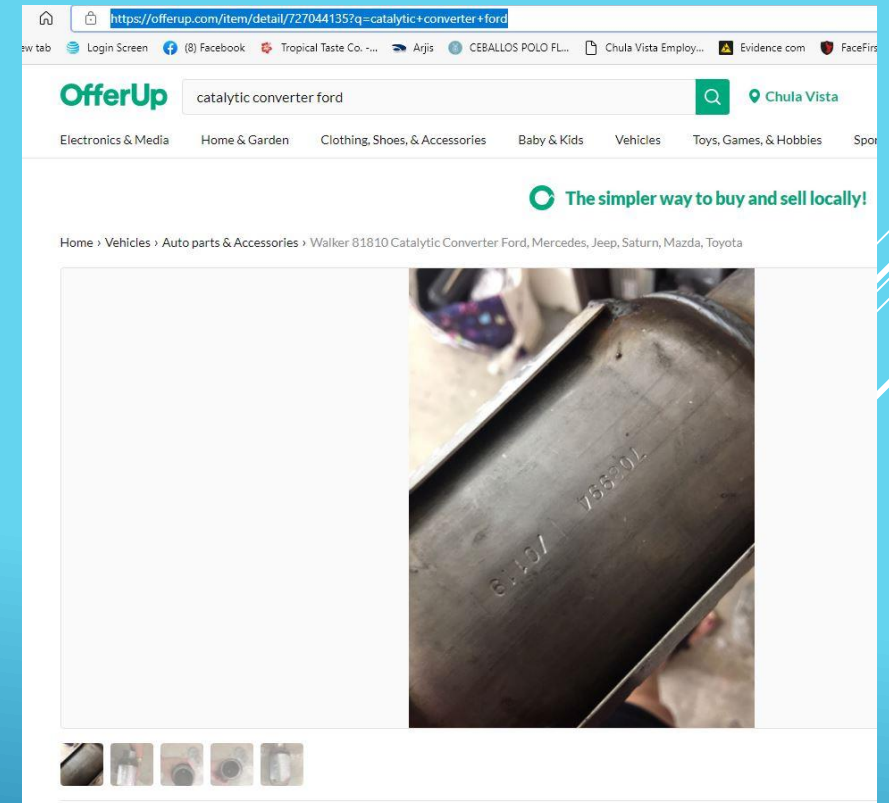

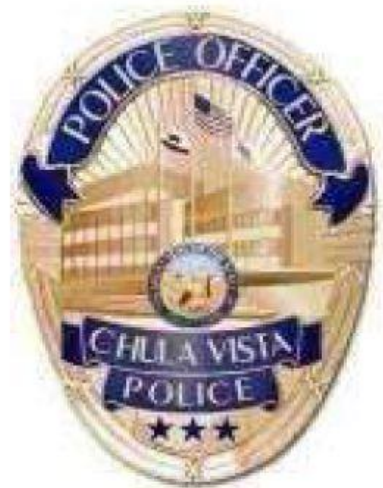

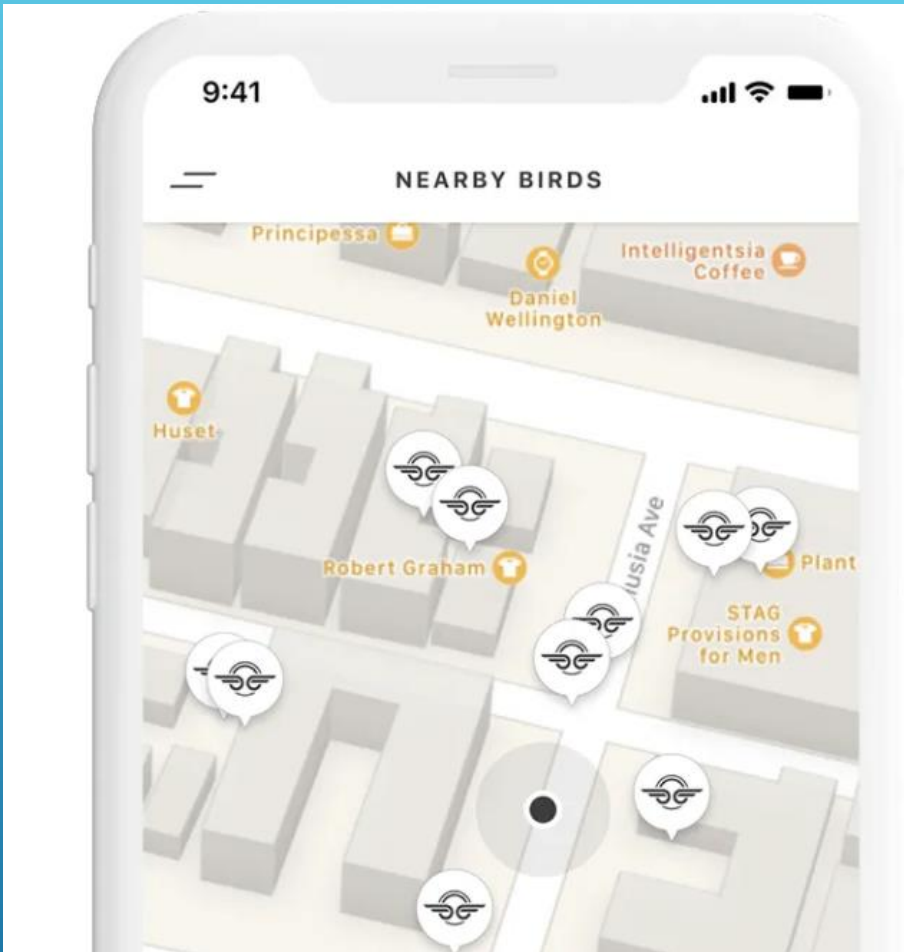

PATROL / DISPATCH GUIDELINES

1. Bird does Knock & Talk.
2. Bird generates a Demand Letter.
3. Bird will Knock & Talk again. Bird would call CVPD for 11-10 if scooter not obtained.
4. The theft report is considered a stale theft (Priority 5 CFS) which can be taken by a CSO via phone.
5. (Extreme Cases) Investigation call out.


Report taking guidelines:

1. Reporting party provides BIRD agreement.
2. Reporting party to provide copy of demand letter.
3. Ensure unique ID number / serial number is collected
4. Collect reporting party information for report
5. Don't need to know last riders' information.

Mobility Services Agreement	
This Mobility Services Agreement ("Agreement") sets forth the material terms of the business relationship described below.	
1. Parties	Bird Rides, Inc., a Delaware corporation, with its principal place of business located at 406 Broadway #369, Santa Monica, California 90401 ("Bird"); and [REDACTED], a Sole Proprietor, with its principal place of business located at San Diego, CA [REDACTED] ("Fleet Manager"; and, together with Bird, the "Parties")
2. Summary	Starting from the Effective Date, Bird and Fleet Manager shall each comply with the term of this Agreement and perform the services described herein (the "Mobility Services") to support Bird's business of renting to consumers ("Users") a fleet of electric scooters within the Territory (as defined below) during the Term (as defined below).
3. Contract Vehicle Fleet	<ol style="list-style-type: none">a) Bird shall designate a specified fleet of its electric scooters (each a "Contract Vehicle," and collectively the "Contract Vehicles") which Fleet Manager shall take full responsibility and possession of solely for use in connection with the Mobility Services. The quantity, type and other details of such Contract Vehicles shall be as specified in vehicle assignment form(s), and may be adjusted from time to time by mutual agreement.b) Unless otherwise agreed in relation to parts or supplies related to Contract Vehicles, delivery shall be at Bird's designated location.c) The Fleet Manager shall collect the Contract Vehicles from the designated location as instructed by Bird.d) As of the date of collection of the Contract Vehicles, such Contract Vehicles shall be in good working condition.
4. Equipment Fee, Balance and Payments; Security Reserve	<ol style="list-style-type: none">a) To set forth the parties' understanding and agreement regarding Fleet Manager's responsibility for its Contract Vehicle fleet, each Contract Vehicle shall have an associated "Equipment Fee" designated upon delivery. In addition, in the event that parts and supplies or repair services provided by Bird that Fleet Manager may need or that are reasonably required for the performance of Mobility Services hereunder are not purchased from Bird or its affiliates and paid for upfront, such items shall also have an associated Equipment Fee as determined by Bird in its reasonable discretion.
