Subject: ***UPDATE*** Shooting on Olympic Parkway at Town Center Drive

This is an update regarding the shooting on Olympic Parkway that occurred on May 4, 2022.

On May 6, 2022, detectives were able to identify and locate the silver Hyundai in the Bonita area. Officers initiated a traffic stop and took two suspects into custody without incident.

Gillio Repetto, believed to be the shooter seen on social media, was a 19 year old resident of Bonita. He was arrested and booked into the San Diego County Jail for attempted murder and assault with a deadly weapon. Serenity Nieblas, believed to be the driver of the suspect vehicle, was a 19 year old resident of Chula Vista. She was arrested and booked into the San Diego County Jail for aiding in the escape of the suspect. There are currently no other outstanding suspects.

The weapon used in this incident has not been located.

The Chula Vista Police Department appreciates and thanks our community, who sent in numerous photos and videos of the incident that were instrumental in identifying the suspects in this case.

On May 4, 2022, at approximately 10:00 A.M., the Chula Vista Police Department responded to multiple calls of a shooting on Olympic Parkway at Town Center Drive in Chula Vista. Preliminary information suggests two vehicles were stopped next to each other at the intersection. A man from each car got out and the two began to physically fight. During the altercation one of the men shot at the other person with a handgun, striking him and then fleeing the scene in a vehicle. The suspect's vehicle was last seen going eastbound on Olympic Parkway. The victim got back into his car and drove while calling 9-1-1. He stopped a short distance away from the scene and waited for first responders. The victim, a 34-year-old Chula Vista resident, was transported to a local hospital where he was receiving treatment for non-life-threatening injuries.

At this time, the relationship between the two men is unknown. The suspect is still outstanding and was described as an adult wearing dark clothing. A description of the suspect's vehicle has not been determined. There is no indication of a continued threat to public safety. This investigation is ongoing and detectives are actively seeking any additional information or witnesses. The incident happened in a busy intersection surrounded by other vehicles.
