My Name is Delfina Gonzalez , I bring diverse roles as a mom, wife , educator ,union member, and small business owner.

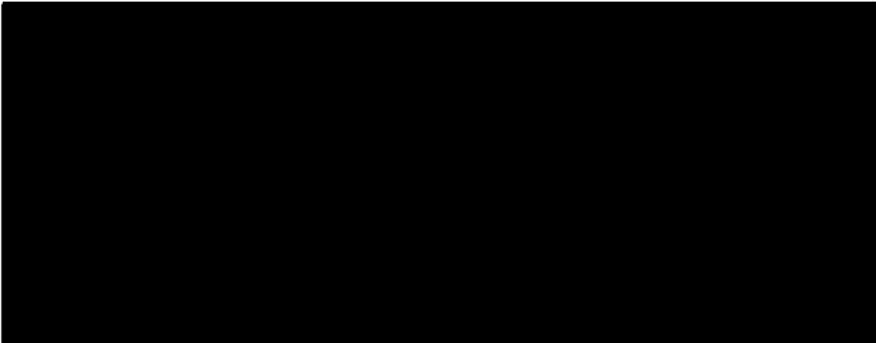
