MEDIA INVITE ONLY - NOT A PUBLIC EVENT

On Thursday, May 2nd, 2023, at 11:30 A.M., the Chula Vista Police Department will be holding a ceremony to honor the officers and members of the community who performed above and beyond in 2023. Their stories are compelling and often go untold. This ceremony helps tell the story of the daily efforts our men and women make to serve others and of the exceptional efforts made by members of the community for the greater good.

• Agent Natalie Garnsey, Officer Donald Truong, and Officer Daniel Hernandez (Life Saving Award)

Just after 11:00 p.m. on Friday, October 13th, 2023, the Chula Vista Police Department received several 9-1-1 calls regarding a vehicle fire on Interstate 5 in Chula Vista. While freeway calls in San Diego County are typically transferred to the California Highway Patrol (CHP), this one caught the attention of a Chula Vista Police sergeant who was listening to the calls for help in real time through Live911.

The sergeant heard the callers' voices and believed someone's life might be at risk. Knowing that officers in Chula Vista would likely be closer than responding CHP officers, the sergeant asked the dispatcher to send Chula Vista Police officers "CODE 3." Although the location of the incident was somewhat unclear and many details were lacking, a Chula Vista Police drone was overhead quickly and the Drone as First Responder (DFR) pilot provided the responding officers with a more accurate location.

Chula Vista Police officers arrived on scene to find a man screaming for his life while trapped inside a burning car on the side of the freeway. The officers worked quickly – battling the flames and their own fears – to reach the man trapped in the car; breaking out a rear window and pulling him to safety just seconds before the car was fully engulfed. It took bravery, teamwork, and tremendous courage. This man is alive in part because of the men and women of the Chula Vista Police Department and innovative technology which played a vital role in his rescue.

When the man awoke from a coma four weeks later, he learned what the officers did to save him. He expressed gratitude and acknowledged how differently things might have ended if not for the actions they took. He said, "I feel like a got a second chance. I'm so appreciative that they were able to get there in time and do what they did. If they didn't, I wouldn't be here today."

The Chula Vista Police Department will recognize the bravery and professionalism of these heroes as they are presented with this award at the ceremony. Chief Roxana Kennedy said, "I want people to see how police officers put their own lives at risk every single day to save people they don't even know. I'm grateful this man survived and so proud of my officers for what they did to rescue him." • Detective Eddie Chavira (Crime Stoppers "Enough is Enough" Award)

Several firearms and dozens of baggies of dangerous fentanyl pills were recovered after the arrest of a violent criminal who assaulted and seriously injured his girlfriend – thanks to Detective Eddie Chavira.

Detective Chavira, who is assigned to the Special Investigations Unit, became involved in the investigation after the arrest, when the department learned the suspect was known to carry firearms. Detective Chavira went to work immediately, advocating to get the suspect placed on a parole hold and obtaining a search warrant to check for firearms. His training and experience steered him in the right course. After serving a search warrant, not only did Detective Chavira and his team recover a loaded stolen firearm, but also dozens of baggies containing fentanyl pills.

Detective Chavira didn't stop there. He had a hunch there was more to the story. He continued his investigation, which uncovered a larger network of criminal activity with multiple suspects involved. Detective Chavira's relentless pursuit of the truth culminated in the seizure of multiple firearms, including AR-15 rifles, ghost handguns, and thousands of rounds of ammunition. A total of five suspects were arrested, four of which pled guilty to felonies.

The Chula Vista Police Department will be recognizing Detective Chavira for his dedication, tenacity, and commitment to serving justice, which exemplify the best qualities of law enforcement officers. His actions in this case undoubtedly made a significant impact on public safety and underscore the importance of specialized units like the Special Investigations Unit in addressing complex criminal activity.

James Moore and Nicolas Castro (Citizen Exceptional Service Award)

In the early morning hours of October 6th, 2023, a single vehicle collided into a tree in the 1500 block of East H Street, catching on fire in the process. It was just after 2:30 a.m., but the sound of the crash caught the attention James Moore and Nicolas Castro, two separate residents in

the area. As the 9-1-1 calls began coming in, James and Nicolas each walked out of their homes and saw the car on fire. James noticed the driver was trapped in the car and hurried to his aid. The driver was unresponsive as the fire started growing in the rear compartment. James and Nicolas worked together in an effort to free the man before the flames reached him. They started breaking the windows and ended up removing the windshield, where they were able to pull the man out to safety just before the car became fully engulfed.

Officers arrived to find the rescued man and a car fully overtaken by flames. Public safety truly is a community effort... had James and Nicolas waited for first responders to arrive, the driver in this incident might not have survived. The Chula Vista Police Department will be recognizing James Moore and Nicolas Castro for their selflessness and quick thinking to save a man's life.
