

RESOLUTION NO. 7257

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA OF INTENTION TO ALTER THE BOUNDARIES OF OPEN SPACE MAINTENANCE DISTRICT NO. 2, AND SETTING A PUBLIC HEARING DATE THEREFOR

The City Council of the City of Chula Vista does hereby resolve as follows:

WHEREAS, it is the policy of the City of Chula Vista to provide wherever possible in new developments, areas of common open space to be jointly maintained, and

WHEREAS, the cost of maintenance of such open space areas is to be borne as equitably as possible between the owners in the district boundary accruing benefits by virtue of the proximity of open areas, and

WHEREAS, the subdivision of Deerpark Chula Vista has agreed to be included in the boundaries of Open Space District No. 2 within the City of Chula Vista.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chula Vista that the following action be taken:


1. The City Council of the City of Chula Vista hereby sets the date of April 23, 1974 at 7:00 p.m. in the Council Chambers of the City of Chula Vista, 276 Fourth Avenue, Chula Vista, California as the time and place for hearing upon the question of annexation of new territories into the existing Open Space Maintenance District No. 2. The boundaries of the territory to be annexed include the following:

Being a subdivision of Lot 1, Lot 2, Lot 4, Lot 5, Lot 6, Lot 7 and Lot A of Woodlawn Park per Map No. 1271 filed in the Office of the County Recorder of San Diego County June 30, 1910, all being in the City of Chula Vista, County of San Diego, State of California.


2. The City Council of the City of Chula Vista hereby directs the City Clerk to give notice by mail to all persons owning property in the area described herein, that the City Council shall on April 23, 1974 determine whether or not the area encompassed above shall be included as parcels to be assessed for the maintenance of Open Space District No. 2. The City Clerk shall mail notices of said public hearing in accordance with those persons whose names and addresses appear on the last equalized assessment role. Following completion of such action, the City Clerk shall file an affidavit setting forth the details in compliance with this section.

3. The City Council of the City of Chula Vista hereby directs that the City Clerk shall publish a notice as provided by Section 6061 of the Government Code no later than April 8, 1974, said date being 15 days prior to the public hearing. The notice shall state the hearing date as April 23, 1974 at 7:00 p.m. in the Council Chambers of the City of Chula Vista, 276 Fourth Avenue, Chula Vista, California, and shall contain a description of the territory or a diagram detailing the territory to be annexed.


