RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA ORDERING CHANGES IN THE FISCAL YEAR 1974-75 ASSESSMENT FOR OPEN SPACE DISTRICT NO. 2 IN THE CITY OF CHULA VISTA

The City Council of the City of Chula Vista does hereby resolve as follows:

WHEREAS, the boundaries of Open Space District No. 2 will be changed by the incorporation of the Deerpark Chula Vista Subdivision, Lots 1 through 14, inclusive, and

WHEREAS, the resolution of the intention of the City Council of the City of Chula Vista to alter the boundaries of Open Space District No. 2 has been duly noticed to the parties subject to such assessment, and

WHEREAS, the inclusion of the additional territory in Open Space District No. 2 reduces the pro rata assessment of each boundaried parcel in said District, and

WHEREAS, the new assessment shall not increase the cost to each assessed parcel in the enlarged Open Space District No. 2, but rather decrease the individual assessments.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chula Vista that the assessment for parcels within Open Space District No. 2 be revised to read that each parcel shall be assessed in the sum of \$28.22 for Fiscal Year 1974-75, vice the current assessment of \$29.91 per parcel.

BE IT FURTHER RESOLVED that the City Clerk be, and she is hereby directed to cause the recording of the notice of the change in assessment in the offices of the County Recorder and County Assessor of San Diego County.

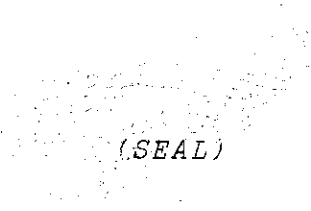


