resolve as follows:

WHEREAS, the notice of the time and place fixed for the
hearing of protests in the matter of the formation of Chula Vista Open
Space Maintenance District No. 7 (Zenith II, III and IV Subdivisions)
under Resolution No. 8337 adopted September 28, 1976, having been
duly given in the manner required by law, and the legal time for
filing such protests and the time fixed for hearing thereon having
passed, and no protests in the matter having been filed.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the
City of Chula Vista as follows:

1. That Chula Vista Open Space Maintenance District No. 7,
the boundaries of which are described in said Resolution of Intention
No. 8337, is hereby ordered formed.
2. The maintenance described in said Resolution of Intention
is hereby ordered performed.
3. The estimated annual maintenance cost of Open Space
Maintenance District No. 7 is \$1,333.25. The assessments have been
spread equally among the parcels lying within the district and the
assessment for each parcel of Zenith II, II and IV Subdivisions is
\$12.82 annually.
4. That the City Clerk of the City of Chula Vista be, and
she is hereby directed to record said assessments in the office of the
County Recorder of San Diego County.
